Town Board Meeting Minutes December 9, 2024

Board Members and Staff Present

Call to Order and Approval of the Agenda

Chairman Fitzwater called the Regular Monthly Fish Lake Town Board meeting to order at 6:00 pm in the Township Office at 2170 Brunswick Road, Harris, MN. The pledge of allegiance was recited by all. Motion made Thill by and seconded by Fitzwater to approve the agenda as presented. Approved unanimously.

Road Report

Gary Guse presented the road report and updated the Board on projects that have been completed and in process from the last month and projects planned for the upcoming month.

Abandon Evelyn Addition (Road): A resident from Evelyn Addition, a short road connecting Cedarcrest Trail and Cedarcrest Lane, inquired about the possibility of abandoning the road. Normally, this process is initiated by a petition to the Board, but it can also be started during an annual meeting. Since the annual meeting is approaching, the clerk will verify the steps required to begin the process.

Extended Warranty 2025 Western Star: The extended warranty options were reviewed, and it was determined that the components that needed to be covered were not included in the extended warranty options and the board decided against purchasing.

2025 Kubota Skid Steer: The board discussed the advantages and approved the purchase of a 2025 Kubota Skid Steer. Owning a skid steer offers several benefits, including the ability to complete tasks inhouse that are currently outsourced. These tasks include brushing, which can save approximately \$7,000 annually, and stump grinding, saving about \$3,000 annually. Additionally, the skid steer can handle small shouldering projects, saving roughly \$6,000 annually. It will also facilitate tree and brush cleanup by loading the chipper with the grappler attachment. Furthermore, it will simplify the process of attaching and removing plow equipment from larger trucks. During snowstorms, the skid steer can reload salt without disrupting the loader's operations, ensuring greater efficiency.
